Promotion Rules

1. Public Notice:

- No Tricks Just Treats is advertised to the public through the monthly calendar, property signage, public-address system announcement and Promotional Rules available at the Player Rewards Booth in the casino and online at jakes58.com.

2. Rules:

- Starting at 12pm, Jake's 58 Club Members who play any Video Lottery Terminal or Electronic Table Game with their Membership Rewards Card properly inserted in the machine during the Promotion Earning Period may receive one (1) Virtual Entry for every one (1) Player Reward Point earned.
- All Virtual Entries that are earned will be maintained by the Player Management System and recorded to the Member's account.
- Virtual Entries are visible to the Member on the gaming machine's Player Rewards Display by selecting the Promos Button.
