## Promotion Rules

1. **Prize(s):**

2. **Public Notice:**

- Surfs Up Mondays is advertised to the public through property signage, public-address system announcement and Promotional Rules available at the Player's Club in the casino and online at [jakes58.com](http://jakes58.com).
